bilge water / waste oil

Enva has over 30 years' experience of removing waste oil/water from ships, with an extensive fleet of oil collection tankers. All waste is removed to our EPA licensed facilities, with certificates of treatment provided after the final treatment operation is complete.



packaged waste

Using a fleet of specialist collection vehicles, along with trained drivers, Enva offer a collection service for hazardous packaged waste including:

- Used oil filters
- Empty oil drums
- Oil contaminated rags
- Oil spill kits
- Aerosols
- Lead acid batteries
- Used paint waste

When collected, the waste is transferred to our EPA licensed facilities, where it is reprocessed to meet the necessary standards and regulations, or exported to the appropriate waste management disposal facilities. Enva will provide all necessary back-up documentation to show that marine vessels are meeting legal obligations for waste removed.





Enva also have a number of D.G.S.A. (Dangerous Goods Safety Advisor) trained employees on hand to give advice. All drivers are trained to internationally recognised standard (ADR) for the carriage of dangerous goods.

grey water

Enva offers a very competitive collection and waste management service for grey water, utilising our own fleet of artic and rigid collection units, trained and experienced operators, along with the convenience of having our own EPA licensed facility for dealing with this waste stream. We have completed numerous projects across short time-frames for cruise ships, naval vessels, super yachts, and so on.




drilling mud

Enva offers a complete solution for removing, transport, and treatment of drilling mud. Key advantages of Enva's offering include the availability of our DISAB unit high power suction unit (9,000 cfm) for the removal of heavy mud over long pulling distances and transfer to road tankers, our fleet of road tankers for transport of this waste, and our licensed facilities for the separation and treatment of this waste stream (all which can be completed without the need for sub-contracting).



tank cleaning services

Enva has vast experience in successfully completing tank cleaning projects on board ships, in difficult circumstances and within restricted timeframes.



cleaning on vessels, such as multiple compartments, tank baffles, height restrictions, high/long suction requirements, and so on. product transfer

This service is a natural extension of the service range offered by our On-site Services division. A recent example includes a project whereby Enva heated and removed heavy fuel oil from 5 tanks on a site adjacent to Dublin Port (storage capacities ranging from 25,000 m3 to 40,000 m3). Enva heated the oil in the all 5 tanks and transferred 105,000 m3 to 5 ships in port. Enva cleaned all oil lines from the tanks to the port when finished.



emergency response

Enva has over 20 years' experience in offering a 24 hour, seven day a week response service, designed to minimise the environmental impact of oil related accidents or incidents, while since October 2008, we can also offer 24/7 HAZMAT (chemical emergency response) service under CEFIC best practise transport guidelines.

Our experience covers oil spills on ships and on water, cleaning of quay contamination and other disasters, foreshore remediation, and on-shore support for marine incidents.

We are members of International Spill Accreditation Association (ISAA), and are the highest accredited company in Ireland. This scheme is acknowledged in Ireland by the EPA, County and City Managers Association, Irish National Accreditation Board, Dept of Environment, Heritage and Local Government, and the Dept. of Transport. We have a number of personnel trained to IMO (International Maritime Organisation) Level 1.
