### Introductory note

#### This introductory note does not form a part of the notice

Under the Environmental Permitting (England & Wales) Regulations 2016 (schedule 5, part 1, paragraph 19) a variation may comprise a consolidated permit reflecting the variations and a notice specifying the variations included in that consolidated permit.

Schedule 1 of the notice specifies the conditions that have been varied and schedule 2 comprises a consolidated permit which reflects the variations being made.

This variation is to permit the increase of on-site storage capacity for hazardous waste listed in table S2.2 (waste oils) from 820 to 1836 tonnes at any one time but maintain the annual throughput volume at 50,000 tonnes per annum. The waste types listed in table S2.2 remain unchanged.

The wastes types and annual limits listed in table S2.3 of the permit also remain unchanged.

As a result of this variation there will be the:

- Removal of 3 existing tanks,
- Addition of 6 tanks,
- Addition of new containment bunds, and modification of existing bunds,
- Additional emission points to air from a tank breathers,
- Increased monitoring on existing tank breather emission points to meet sector BAT requirements, and
- regularise and updated the hazardous waste storage.

The waste materials handled and the treatment processes employed on site will continue to be the same. The will be no increase in the treatment capacity at the site.

The rest of the facility is described as follows:

The facility is currently permitted to manufacture Processed Fuel Oil (PFO). PFO is used as a virgin fuel substitute in a variety of large industrial burning applications and undertake waste operations on a variety of hazardous and non-hazardous waste.

The facility is divided into 4 areas – two processing areas and two office facilities. The centre of the site is at National Grid Reference SK65256060.

The processing site and offices covering an area approximately of 400 000 ft<sup>2</sup>. This includes the wooded area screening the site along Eakring Road.

The site is enclosed within a two metre high chain link fence topped with 3 strand barbed wire except for the eastern boundary which has a two metre high palisade fence along the access road approach to the site. Access to site is by one of two lockable gates with the northern access limited further by a remotely controlled barrier.

There are vehicle dismantlers and landfill operations to the east of the site and secure vehicle storage facilities to the north.

There is a dense area of shrubs and young trees to the western boundary which screens the plant from domestic properties some 180 metres away to the west.

Birklands and Bilhaugh SAC are 7 km from site. The River Greet is approximately 1km away and Rainworth Water is 1.1km from the site.
