Enva Wood Recycling Group Site rules.










No Smoking: All Enva sites are **No Smoking**, this includes inside cabs and vehicles. Smoking is only allowed in designated places. If required, ask for the Smoking area to be shown to you.

Site Speed limit is 5mph. Pedestrians and heavy plant operate on site.

Pedestrian crossing and pedestrian walkways must not be obstructed. Do not park or wait blocking the walkways or crossings.

Mobile phones are prohibited. Do not use a mobile phone whilst on our site, their use causes distractions that could ultimately lead to an accident.

Covid-19.




Maintain social distancing at all times.

Do not enter site if you feel unwell.

Only enter buildings if required

Wash your hands frequently



PPE requirements.









PPE must be worn whenever out of the vehicle. Drivers without the required PPE will not be allowed on site.



First Aid & Fire arrangements.



Fire action. The Fire muster point will be indicated to you on arrival. In case of fire, follow instructions given by Enva staff.



First Aid. Aiders may be easily identified whilst on site by the First Aid logo on hard hats.

ALL vehicles tipping or collecting loads must:

Enter site via weighbridge and visit site office with paperwork.

Queue, if necessary at load inspectors hut.

Remove sheeting then wait in vehicle.

Progress onto site only under instruction from load inspector.

When opening skip doors, keep the door between you and load.

Lower skips immediately after tipping and close the doors.

Sheeting up MUST be done at the gantry.

Important:

Accidents / near miss: Report all accidents and near misses to Reception or a First Aider

DO NOT:

Progress past the Load Inspectors hut without being instructed.

Travel with skips raised.

Stop on pedestrian crossing points.
