What is **sustainability**, and **why does it matter?**

What are the United Nations **Sustainable Development Goals** (SDGs)?

Sustainability means using resources responsibly, so we don't harm the planet or limit opportunities for future generations. Right now, we're using Earth's resources too quickly, leading to issues like climate change, pollution and harm to communities. One of the most effective ways to address this is by changing how we produce and consume goods.

The United Nations created 17 **Sustainable Development Goals** (SDGs) **to help make the world a better place.**

These goals cover a wide range of global priorities, from clean energy and waste reduction to protecting nature and improving people's lives.



Many organisations choose to focus on a few goals to guide their work. Doing so not only supports global sustainability efforts, but helps build brand trust, reduce risks and costs, comply with current and future regulations, attract investors, and recruit and retain top talent.



What are Enva's goals?

Core



At our core, Enva's circular products and services help to protect and preserve the worlds finite resources, supporting Responsible Consumption and Production (**Goal 12**).

Facilitator



We achieve this through partnerships with customers to innovate the critical infrastructure we manage (**Goals 17 & 9**).

Outcomes



The outcome of this focus is that Enva delivers action on the climate crisis (**Goal 13**), improves the sustainability, health and well-being of communities (**Goal 11 & 3**), provides cleaner water (**Goal 6**) and improves life on land and sea (**Goal 14 & 15**).



Why is this important for Enva?

Sustainable Solutions

What does it mean?

Offering products and services that help customers be more sustainable.

What is our target?

We ask our staff and customers how important sustainability is to customers when they talk to them.

Why does it matter?

This helps Enva invest in the right areas to lead the industry and exceed customer needs.

Enva sets targets and **tracks progress against four main areas** to help deliver our SDGs.



Circularity

What does it mean?

It means recycling more of the material we handle for customers and sending less of it to landfill.

What is our target?

By 2035, at least 68% of material Enva handles should be recycled, and a maximum of 10% should go to landfill.

Why does it matter?

The independent body that governs the UK's approach to the climate crisis and the EU say these targets are vital to achieve the UN SDGs. These targets are supported by the Environmental Services Association.

Communities



What does it mean?

Improving the wellbeing of Enva staff and the communities that live in the areas we operate in by focusing on improving their inclusion, diversity and equality.

What is our target?

We track our staff wellbeing through several metrics and measure the extent of our local community's engagement through charitable volunteering endeavours.

Why does it matter?

This ensures Enva improves society by directly improving the lives of staff and communities as well as protecting their local natural environment.

Decarbonisation



What does it mean?

Cutting down on carbon emissions.

What is our target?

Reduce emissions

42% by 2030 compared to 2022

Why does it matter?

The United Nations has made it clear: achieving the Sustainable Development Goals is vital to avoid the worst impacts of the climate crisis. The actions we take now will define the kind of world we live in.

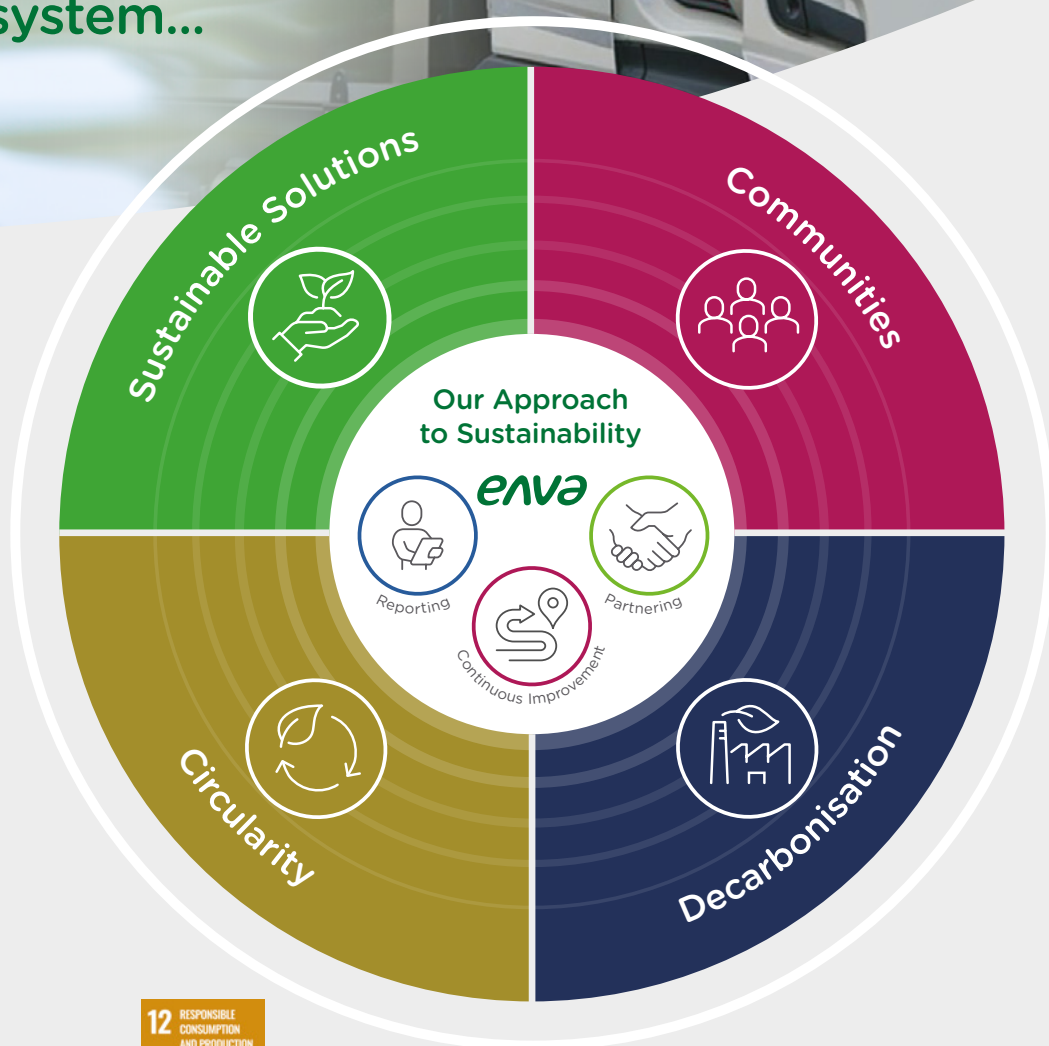


Partnering

The sustainability team work with every part of Enva to provide frameworks, develop tailored solutions, and help manage projects that deliver the targets. This collaborative and partnership approach responds to the broad range of services and products Enva offers, giving each part of the company the opportunity to find the best way to deliver the targets. For example, using HVO instead of diesel works for decarbonising some vehicles, but electric vehicles are better for others. Nevertheless, some projects benefit from the sustainability team facilitating a more group-wide approach by bringing multiple parts of Enva together to collaborate.
